Purpose of Report

The purpose of this report is to provide an update on the development of strategies to support the Trusts Integrated Business Plan. The approvals process and timelines leading up to the final IBP submission in July 2012 is also outlined.

A revision of the strategy map is attached which depicts a tiered approach to ensuring the strategies are reviewed through the introduction of an internal reader panel, independent review, including SHA Subject expert review through to formal Trust Board approval in April, May and June. The table provides a summary of where each Strategy currently is within the authorisation process.


